2. Tobacco Presentations with USD497	<p>Laura, Aftan, and Allison have been presenting to 6th, 8th, and 9th graders in Lawrence, requested by USD497. Eudora is interested in providing vaping education and updating their policies to perhaps implement onsite cessation groups to students.</p> <p>Lawrence High schools and Eudora High and Middle schools now have Sources of Strength chapters within each school which are carrying forward the work of the Douglas County Youth Prevention Board (now DCYP), and includes the RESIST tobacco/vape education. There may be an opportunity to have DCYP/RESIST youth present to the their peers within the schools about vaping/tobacco.</p> <p>There are opportunities within the Pathways grant to fund vaping/tobacco education within K-12 schools as well as a RESIST chapter package to expand the work of RESIST. Laura will work with school chapters to see if there are any funding needs.</p>	
3. Tobacco Ordinance Update	Adding vaping to the clean indoor air ordinance will be heard at the October 19 th commission meeting. The Tobacco Retail License ordinance will be heard later this year. American Heart Association will remain more neutral during the vaping presentation but	We can update those that attended last time so they are aware of the October 19 th commission meeting

4. Request from LWDC Leadership	Create a purpose statement for Tobacco Free Living work group and discuss goals which come from Pathways/CDRR.	
5. College Policies Update	<p>Aftan met with an HR director at KU to discuss improving tobacco policies and identifying who is the appropriate point of contact going forward. Another meeting will be set up to discuss specific policies and how they are enforced, including tobacco promotions and ads within school media like the UDK. Hookah House currently promotes their business in the UDK school newspaper.</p> <p>Shonnardo (Laura's intern) met with Dr. Holt at Baker to set up a meeting for Oct 7th with members of TFL to discuss some potential steps for improving policies at Baker. Currently, Baker allows smoking 25 feet outside of buildings on campus and have designated smoking areas. We hope to get youth health organizations on campus involved with the work.</p> <p>Laura will be presenting about tobacco disparities and the history of targeting by tobacco companies during the October 9th Art Show which is hosted by the Indigenous Community Center and will be at Sacred Ground Haskell. The event is 3-7 and the presentation is at 6. Jason Hale from AIHREA and All Nations Breath of Life will be presenting about the use of traditional and sacred tobacco.</p>	<p>Meet with staff at KU and Baker to discuss next steps.</p> <p>Need to identify a contact at Haskell</p>
6. Open Space	<p>Can add information bout presentation to the commission as well as tobacco prevention education.
